

#### **ABSTRACTS SUBMISSION GUIDELINES**

Authors wishing to submit abstracts by 15 September, 2023 need to follow these requirements:

- Abstracts should be submitted in Albanian and/or English language.
- The format of the abstract needs to comply to:
  - up to 350 words
  - document "MS Word file"
  - Times New Roman font, 11pt.
- The abstracts should include the following additional information:
  - Title of the Presentation/Full Paper.
  - Author name/Position/Institution/Country
  - Personal Contacts (e-mail, mailing address, and telephone number)
- The Relevant Conference Topic.
- The Objective of the Paper, the main issues/ problems, the methodology used and the results and conclusions drawn.
